After joining the meeting, please **enter your full name and old staff number in the CHAT box** so that your attendance at the AGM is recorded.

To ensure smooth conduct of the AGM with audible proceedings, all participants will be muted except the speakers/ office bearers. All communications, comments and questions will be addressed via the chat box.

At the completion of every Agenda point, we will address any questions or comments typed out in the chat box pertaining to that particular subject. We will also address any queries entered in the chat box after covering all the Agenda points.

When we convey need of proposers and seconders for resolutions, members may type their names in the chat box.

In case you get disconnected from the meeting for any reason such as Wifi or internet connectivity, please re- join as soon as possible.

A frequent issue noticed at such meetings is that some members have 'audio" issues and cannot hear. In such a case, first check the audio setting level on your own device. You may also need to quit and re-join the meeting to resolve the issue. Use of ear phones or head phones will help prevent and resolve audio issues.

You will find it easier to participate using devices with bigger screens like desk tops, lap tops and I- pads rather than smart phones.
