As advised in our GHIP announcement newsletter dated 25 August 25, this year we will be using our brokers website for enrollment of GHIP 25-26. The link for the same has been provided under the process of registration explained below.

**PLEASE ENROLL THROUGH THIS LINK ONLY IF YOU ARE OPTING FOR THE BASE POLICY OR COMBINED BASE PLUS SUPER TOPUP POLICY.**

**Those who wish to avail of only the super top up policy without the base policy will be informed about the enrollment details link shortly.**

You will be able pay your chosen premium for both base as well as Super Top Up policy online through Easebuzz payment gateway while enrolling on the website.

You will also continue to have the option to pay offline, directly into our ICICI GHIP bank account through NEFT/cheque deposit as per details below

**In case of all payments offline or online, enrolment via the link provided below is compulsory.**

Also in case of offline payment/direct deposit it will be the members responsibly to ensure that the premium is actually deposited into our account. Hence please ensure that your account is duly debited within a reasonable time frame.

In addition those who are paying offline should send an email to [ailrea.ghip@gmail.com](mailto:ailrea.ghip@gmail.com) providing the relevant information about the premium paid. This will enable us to tally who has made a direct deposit into our account.

### **PROCESS FOR ONLINE REGISTRATION**

1. **This year the registration will be linked through the broker's website.**

**PLEASE READ THROUGH THE STEPS GIVEN BELOW BEFORE YOU ACCESS THE SITE.**

**IF YOU ARE MAKING THE PAYMENT OFFLINE, PLEASE DEPOSIT THE CHEQUE OR MAKE THE NEFT PAYMENT BEFORE YOU START THE ENROLLMENT. PLEASE ENTER YOUR STAFF NO AT THE BEGINNING IN THE REMARKS COLUMN**

2. Click on <https://ailrea.premiumbima.com>
3. Enter your staff number and your personal details will be displayed. PLEASE EDIT THE DETAILS IN CASE OF ANY ERRORS.
4. Click on "I confirm all details are correct and I agree to the indemnity clause"
5. Select your base policy. ....Self or family floater and the Sum insured. The premium amount will be auto populated,
6. Click on "I have read the base policy Terms and Conditions"
7. If you wish to take **ONLY** the base policy, click on "continue to payment"
8. IF YOU WISH TO CONTINUE BY ADDING THE SUPER TOPUP POLICY, the deductible and sum insured will be prepopulated.
9. **PLEASE CLICK ON THE BOX "I have read and agree to the Super top up terms and conditions, and I also want to add a Super top up premium of ₹XXXXXX to my total payment."**

**10. The total of the base policy and the Super top up policy will be displayed**

11. **Total premium calculation MUST show the total of base and super topup policy.**
12. Summary of enrollment will be displayed with an edit button in case any errors need to be rectified.
13. Proceed to payment either through the Easebuzz payment gateway or submit details of payment already made by selecting the relevant options
