We have gathered information from social media on the above subject and are reproducing the same for your benefit.

Mr. Rajiv Kapoor, Chief Financial Officer, AIAHL, has written to Chief Human Resources, Air India, that, an online portal:

has been activated for submission of medical claims.

AI discontinued

(1) OPD facility from 18th Oct 2022 to retirees who had their CGHS yellow cards then.

(2) AI had stopped IPD service for all retirees from 01st Jan 2023.

Both the categories of retired employees can now log in and submit their claims for reimbursement through the online portal, as given.

Those who have made previous payments for OPD, from 18, October 2022, can now get reimbursed following the online procedure.

IPD reimbursement will now be accepted effective 01 January 2023

Those retirees who are still NOT in possession of their CGHS cards, may please keep your original bills, referral letters and reports (for submission) until such time till you have got your YELLOW CGHS card. After that you can get your reimbursement following the same procedure.

It is also stated in the letter that implementation of cashless IPD and OPD referrals is underway.

A separate notification will be issued accordingly.
