After a gap of 3 years we are very happy to announce a fun event, a picnic on 18th January 2024.

We are fortunate that our member Mr Raj Elisha has generously offered to host us at his property, Crimson Fern Villa at Badlapur.

We will arrange to hire an A/c luxury bus as per following route and timings:

Colaba, Cusrow Baug 0645 a.m.

Tardeo, Sethna Agiary 0700 a.m.

Dadar TT, Dayaram Damodar 0720 a.m.

Chembur, Shivaji statue roundabout 0740 (bus will get off Expressway and make a right turn and stop near south Indian restaurant)

Vashi 0810 a.m. just after toll naka

Our Bus will travel via the Eastern Expressway via Sion, Chembur, and Vashi, reaching our destination in about two and half hours.

The only mall on the way does not open till 11am hence we regret that we will not be able to make a stop for using restrooms.

A light breakfast will be provided on the bus. However please carry your own water bottles which can be refilled for the return journey.

Veg and nonveg biryani with raita will be served for lunch from a local restaurant.

The return journey will start at 4 pm from the resort after tea and follow the same route in reverse order. Due to traffic the return journey is expected to take longer.

The cost for the picnic will be subsidized and you are required to pay only Rs 550/- per head while registering for the picnic on our website.
